**ORDER DENYING DEFENDANT
JULIE TAGEN'S MOTION
FOR SUMMARY JUDGMENT**

Upon consideration of Defendant Tagen's Motion for Summary Judgment ("Motion"), Plaintiff's Consolidated Opposition to Defendants' Motions for Summary Judgment thereto ("Opposition"), and the record herein, the Court denies the Motion because of the genuine issues of material fact in dispute, which include but are not limited to the following: (1) whether Defendant Tagen mischaracterized Plaintiff's statement regarding African Americans and whether the statements made were defamatory¹; and (2) whether she aided and abetted the Democratic National Committee ("DNC") by participating in a scheme to

discriminate and retaliate that resulted in Plaintiff's termination of his position at the DNC.
